If the Renter fails to provide such notice in writing (Receiving Report) within 2 day(s) after the delivery of the display, the Renter will be conclusively presumed to have accepted the display in its currently recorded condition. Any subsequent claim that the display was damaged previous to delivery or in transit will not be considered.

All attempts to ship packages via FedEx Ground will be made to minimize shipping costs, however, shipping costs will vary depending on the Renter and next Renter's locations and deadlines for receiving. The Renter agrees to pay all receiving and forwarding shipping costs, regardless of the amount.
